Counselling and Online Test Schedules for M.Tech., MUP and M.Sc. Programmes 2023

The schedule of counselling and online test for the M.Tech., MUP and M.Sc. programmes 2023 of the Institute is as given below. Those candidates who have applied and are eligible for the respective programmes (as given in the PG Information Brochure 2023 (pdf) on the Institute website) should attend counselling for GATE qualified candidates and online tests and counselling/interview of Non-GATE candidates on the date given below.

Candidates may please note the following:

- Eligible candidates who have applied for the M.Tech., MUP and M.Sc. programmes, including sponsored candidates, to be available on email and mobile phone by **8:30 am 20th June 2023**. The schedule may be extended to 21st June 2023, where large number of candidates are there.
- The **Test/ Counselling** for each programme will be **online**.

At the time of the counselling, candidates will be required to produce(show online) the following documents and certificates in original.

1. Pass certificate of Class 10
2. Marksheet of Class 10
3. Marksheet of Class 12 / Intermediate or equivalent
4. Certificates and marksheets of graduation / qualifying examination OR

Marksheets up to pre-final year for candidates who would be completing qualifying examination in 2023.

Candidates with qualifications acquired through correspondence or distance-learning programmes must show proof of pass certificate, marksheets of qualifying examination and approval of DEC (Distance Education Council).

5. Admit card and Score card of GATE (if applicable).
6. Caste certificate / special category certificate (if applicable).
7. Photo identification: (Driving license, Passport, PAN Card, Voter ID, Aadhaar Card, College ID, Employee Identification Card are acceptable).

Provisionally selected candidates will be required to submit all the above Documents / Certificates (except photo ID) in original at the time of admission.

Provisionally selected candidates who have appeared for final examinations in 2023 will be required to sign an undertaking at the time of admission on Non-Judicial Stamp Paper of Rs. 20/- to the effect that if they fail to obtain the requisite marks in graduation / postgraduation their admission will be automatically cancelled. The deadline for submission of mark-sheet / degree certificate is 31 October 2023, failing which the provisional admission will be cancelled. (Please see PG Information Brochure 2023(pdf) on website for format of undertaking). ERP Payment link will be shared to provisionally selected candidates through email. Candidates should visit our website <http://www.bitmesra.ac.in> periodically for updates or any other matters related to the admission procedures. The Institute also reserves the right not to offer a particular programme in case the number of students found to be eligible to be admitted is less than 30% in number.
