### Second provisional selection list for B.Pharm programme 2016 at Mesra

Further to our previous notification Ref/Mesra/Results/2016-17/BPharm/Results -3, dated 01 September 2016, the following candidates from the waiting list are also provisionally selected on merit for the full-time Bachelor of Pharmacy (B.Pharm) programme 2016 at Mesra, based on their marks obtained in Class 12 / equivalent examination & JEE-Main 2016 / NEET-UG 2016 [60% weightage to marks obtained in JEE-Main 2016 / NEET-UG 2016 and 40% weightage to marks obtained in Class 12 / equivalent qualifying examination] and subsequent counselling held on 1st September 2016. The list is being placed only on the Institute website and Notice Boards at Mesra.

All provisionally selected candidates are required to report in person for admission **at Mesra** during working hours on working days **by 05 Sepetmber 2016**, failing which their admission offers will be cancelled, and vacant seats will be allotted to waitlisted candidates.

At the time of admission provisionally selected candidates will be required to submit /show the following documents / certificates in original:

- 1. Pass Certificate of Class 10
- 2. Marksheet of Class 10
- 3. Marksheet of Class 12 / I. Sc. or equivalent
- 4. Admit Card of JEE -Main 2016 / NEET-UG 2016
- 5. Score Card of JEE -Main 2016 / NEET-UG 2016
- 6. School / College leaving certificate
- 7. Migration Certificate
- 8. Originals of caste certificate (if applicable). Caste certificates must be in proper format, signed by appropriate authority of rank not less than SDO.
- 9. Originals of being physically handicapped / other special category certificates (if applicable). Candidates belonging to Persons of Disability (PwD) / other special categories mentioned in brochure must have relevant certificate(s) in proper format signed by appropriate authority.
- 10. Photo identification: (Driving license, Passport, PAN Card, Voter ID, School /College ID / Aadhaar Card are acceptable).

#### Total fees payable at the time of admission:

Provisionally selected candidates will be required to deposit an amount of **Rs.1,24,000**/- by crossed demand draft in favour of "**Birla Institute of Technology**", payable at **Ranchi** for admission to B.Pharm programme at Mesra.

As mentioned therein, students admitted at Mesra will be required to deposit Hostel Caution Money\*\* (One Time only - Refundable) of Rs.5,000/-. They will also be required to pay suitable mess advance at the beginning of each semester, which will be adjusted against their mess charges. For the July 2016 session, this mess advance\*\* will be Rs. 20,000/- [Total of Rs. 25,000/-].

\*\*Hostel Caution Money (One Time only - Refundable) and Hostel Mess Advance (each semester) are payable by crossed Demand Draft in favour of "BIT Hostels Mess Account" payable at Ranchi.
