Candidates may please note the following:

All applicants are advised to check their seat allotment / result online on the Admission Page of Institute website. Provisionally selected applicants will be required to pay the admission fee (for 1st Semester) using Online Payment Gateway in our ERP through debit / credit card and net banking of any nationalized bank (URL given below) **by 07th August 2023**, failing which their admission offer is liable to be cancelled and will not be considered for further round of seat allotment, if any. Subsequently, after fee payment, candidate should report to allotted campus within a week to complete the document verification.

FEES PAYABLE: Applicants will be required to pay admission fee (1st semester) i.e. **Rs. 1,11,700 for Deoghar (hostel charges included) and Rs.96,700/- for Lalpur, Jaipur, Noida and Patna Off Campuses**, using Online Payment Gateway in our ERP through debit / credit card and net banking of any nationalized bank by the due date.

No hostel accommodations are available at Lalpur, Patna, Noida and Jaipur Off Campuses. Hostel

facility is available at Deoghar Campus.

ENROLLMENT NUMBERS: Institute enrollment numbers will be issued after receiving the admission fee and document verification.

CLASSES SHALL TENTATIVELY BEGIN FROM LAST WEEK OF JULY (EXACT DATES SHALL BE NOTIFIED IN ACADEMIC CALENDAR FROM DEAN (UNERGRADUATE STUDIES) OFFICE). YOU ARE ADVISED TO VISIT THE INSTITUTE WEBSITE PERIODICALLY FOR UPDATES.

VERIFICATION OF DOCUMENTS: The document verification shall be done at the allotted campus. In case, any information/document provided by the applicant online is found to be incorrect / inaccurate / false, the admission of such applicants is liable to be cancelled and all fees paid by the applicant shall be forfeited. Decision of the Vice Chancellor, BIT Mesra will be final in such matters.

Applicants will be required to furnish the following documents/certificates in original as well as one set of photocopies during verification of documents at a later stage.

1. Pass Certificate and Marksheet of Class 10
2. Marksheet of Class 12 / Intermediate or equivalent
3. School Leave Certificate (SLC)
4. Migration Certificate
5. Caste certificate (if applicable), in proper format, signed by appropriate authority of rank not less than SDO.
6. Special category certificate (if applicable), in proper format, from appropriate authority.
7. One recent passport size photograph, identical to uploaded on the Application Form.

Note:

- a) Applicants will be required to submit School Leaving Certificate, Migration Certificate and Caste certificate in original. Rest documents / certificates may be withdrawn immediately after verification and by submitting "Undertaking Form" available in the Admission Office.
- b) For fee refund rule, please see separate notice on Notice Board of the Institute.
- c) It is desirous that students offered admission to any of the campuses of the Institute should have the minimum requirements to engage themselves in online activities of the Institute. (i.e. Laptop / Personal Computer and basic internet connectivity).
