

## **The “ BIT G. P. Birla Scholarship ” Scheme**

For over six decades, BIT Mesra, Ranchi has been engaged in nurturing minds through academic excellence. The “**BIT G. P. Birla Scholarship**” scheme has been instituted, to encourage meritorious students and to ensure that they are not denied the BIT education because of lack of means.

- The total scholarship amount will be Rs 2.10 crores per annum. If the total number of students becoming eligible for the scholarships in accordance with the criteria as specified below exceeds the numbers who can be accommodated within the total earmarked yearly sum of Rs 2.10 crores for scholarships, then the eligibility criteria will be revised at the discretion of the Institute, to restrict the number of students who will be granted scholarship so that the aggregate sum of scholarships granted in a year does not exceed Rs 2.10 crores.
- The scholarship amount will cover part or whole of tuition fee and hostel seat rent, while in some cases, it may be limited only to tuition fee.
- The scholarship commences from the first semester itself for students who have secured the prescribed JEE ranks. Other students will have to pay full fees at the time of admission and scholarship will commence for them, as and when they become eligible.
- Scholarship certificate will be awarded to selected students.

**1. Merit scholarships on the basis of JEE Main Rank:**

First semester students admitted in different branches at BIT Mesra, Ranchi will be eligible for this merit scholarship based on their JEE Main Rank.

Continuation of scholarship beyond first semester shall be based on GPA secured by student as per the norms mentioned below:

<b>GPA</b>	<b>Scholarship Per Semester</b>
>9.5	100% Tuition fee
>9.0 – 9.5	75% Tuition fee
>8.5 – 9.0	50% Tuition fee
8.0 – 8.5	20% Tuition fee

## **2. Merit-cum-means scholarship:**

This scholarship amount for eligible students shall be determined based on their performance in the previous semester as well as their parents' annual income (from all sources). Eligibility criteria shall be as under:

a) Parents' annual income must not be more than Rs 3 lakhs

b) Merit as per the norms mentioned below:

<b>GPA</b>	<b>Scholarship Per Semester</b>
>9.5	100% (Tuition fee + Hostel seat rent)
>9.0 – 9.5	75% (Tuition fee + Hostel seat rent)
>8.5 – 9.0	50% Tuition fee
8.0-8.5**	20% Tuition fee

\*\* Only for BE/BArch. students

The income certificate of parents must be issued by a gazetted officer not below the rank of Circle Officer. The number of scholarships in this category shall be proportional to the total number of students in each programme .

## **3. Sudden demise of earning member of the family:**

In cases of students facing financial hardship due to sudden and untimely demise of the sole earning member of their family, the Institute shall provide 100% tuition fee waiver for the current semester and a scholarship of up to 75% may be offered in the subsequent semesters, on case to case basis, depending on means, need and the overall performance / discipline of the student. To be eligible for this scholarship, a student must have secured

GPA not less than 7.5 in the immediately preceding semester and thus this scholarship shall be available only from the second semester onwards.

**Note:**

- This scholarship scheme is applicable only for students studying at Birla Institute of Technology, Mesra campus.
- At any point of time, a student can avail only one scholarship.
- The decision of the Institute on all matters for grant of scholarship shall be final and binding.
- The Institute reserves the right to amend/discontinue the modalities as well as the types of scholarship schemes at any point of time.
- If a student is found guilty of any misconduct/indiscipline, his/her scholarship shall stand discontinued.
