Applications are invited for the post of a Junior Research Fellow (JRF) in the following research project funded by SERB in the Department of Civil and Environmental Engineering, BIT, Mesra, Ranchi, Jharkhand

**Title of the project:** *Source Apportionment, Hydrodynamic Study and Environmental Fate Assessment of Micro-Plastics in Drinking Water Supplying Reservoirs of Ranchi, Jharkhand*

**PI:** Dr. Sukalyan Chakraborty, Associate Professor

**Project duration:** 3 years (36 months), the post is temporary and co- terminus with the project

**Eligibility:** B.E / BTech / M.E. / MTech in Environmental Science/Engineering, M.Sc. in Environmental Sciences / Life Sciences / Chemical Sciences with GATE/ NET or similar other national level examinations (Candidates without GATE/ NET or similar other national level examinations can also apply and would be considered for the post of Project Associate-I). Knowledge in GIS & Remote Sensing is desirable.
