General Terms & Conditions:

1. The above position is **purely temporary** and will be filled on contractual basis. The position is co-terminus with the project and will be offered initially for a period of 06 months or till termination of the project whichever is earlier. However, the tenure may be extended depending upon the requirement and performance of the candidate.
2. The selected candidates shall not claim for any regular appointments at this Institute / ICSSR, as the above positions are purely contractual, non-regular, time bound and are co-terminus with the project.
3. The candidate must exhibit capability to adhere to strict timelines and discipline. Non-maintenance of the discipline and failure to perform the assigned duties will make the candidate liable for termination during the appointment period. The Field Investigator may also leave the assignment, on their own volition, by giving one-month notice.
