Students registering for backlog course(s) shall pay a fee of Rs.5,000/- per backlog course.

Students are advised to attend lab classes mandatorily after registering the lab course and further advised to check the time table before registering the *lab course* and get the time table endorsed by the Head of the Department and also ensure that time table should not clash with the courses already registered in SP-20.


Note
